(Application of these terms and conditions)

Article 1.The users of this facility are requested to use the facility in accordance with the following terms and conditions. Matters not stipulated in these terms and conditions shall be governed by law or custom.

(Refusal of use)

- Article 2. The facility may refuse use in the following cases, or may not be used in whole or in part In such cases, the facility may not be able to be used. In such cases, the facility will not be responsible for any intentional or gross negligence on the part of the facility. The fee will not be refunded except in the following cases
 - (1)When a user is found to be likely to commit an act contrary to the provisions of laws and regulations, public order, or good morals. When it is seen.

Article 16. These General Terms and Conditions shall be written in Japanese and English, but in the event of any inconsistency or difference between the two texts of the General Terms and Conditions, the Japanese text shall control in all respects.

- 1. The following items are not permitted in the facility

- 2. The following activities are not permitted in the facility.

- 7. No stay beyond 24 hours is allowed. If you wish to continue your stay, you will be required to settle the previous charges (if you fail to settle the previous charges, you will not be allowed to stay any longer).
